ORDINANCE NO. 02-2019

ORDINANCE AMENDING City Code 6-2-6 OF THE CITY OF ATHENS, MENARD COUNTY, ILLINOIS

WHEREAS, the City Council of the City of Athens, Menard County, Illinois, has determined to amend City Code 6-2-6, City of Athens Water Rates and Charges

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ATHENS, MENARD COUNTY, ILLINOIS:

City Code 6-2-6, Rates and Charges be amended by deleting paragraph (e) of said Ordinance and replacing it with the language indicated in bold below:

6-2-6: RATES AND CHARGES: ©

- A. Rates And Charges Established: For each person or entity using city water, the rates shall be as follows: (Ord. 01-2015, 3-9-2015; amd. 2017 Code)
- 1. Inside City Limits: For users situated inside the city limits, the rates are as follows: First two thousand (2,000) gallons or less, twenty four dollars forty five cents (\$24.45); four dollars ninety seven cents (\$4.97) for each additional one thousand (1,000) gallons or fraction thereof.
- 2. Outside City Limits:
- a. Rates for users situated in the areas known as Fancy Creek Area shall be as follows: First two thousand (2,000) gallons or less, thirty one dollars thirty six cents (\$31.36); nine dollars (\$9.00) for each additional one thousand (1,000) gallons or fraction thereof. (Ord. 01-2015, 3-9-2015)
- b. Rates for users using Menard rural water shall be as follows: Six dollars four cents (\$6.04) per one thousand (1,000) gallons (effective January 5, 2015). (2017 Code)
- c. Rates for users situated in all other areas outside the city limits not otherwise provided for shall be as follows: First two thousand (2,000) gallons or less, twenty nine dollars fifteen cents (\$29.15); seven dollars sixty one cents (\$7.61) for each additional one thousand (1,000) gallons or fraction thereof.
- d. Bulk weight rates shall be thirty five cents (\$0.35) per each twenty nine (29) gallons.
- e. The rates established in this section shall increase by three percent (3%) on June 1, 2019, and a minimum of two percent (2%) on May 1 each year thereafter unless otherwise amended by the Athens City Council.

and, from time to time, amend rates for water usage by users outside the city limits. (Ord. 01-2015, 3-9-2015)

This Ordinance shall be in full force and effect from and after its passage and publication as provided by law.
